Information Technology in a Global Society

Welcome to the Information Technology in a Global Society course. This standard level IB course is designed to explore the global impact of information technology. This course is in IB Subject Group 3: Individuals and Societies and is an elective course. Students will fulfill the district CTE requirement by successfully completing this course.

Course Overview

The aims of the information technology in a global society course at the standard level are to enable candidates to:

1. Develop an understanding of the advantage and disadvantages of new technologies as methods of expanding our knowledge of the world at the local, national and global level.
2. Promote an understanding of the social significance or information technology for individuals, communities and organizations.
3. Analyze and evaluate the ethical considerations arising from the widespread use of information technology at the local, national and global level.
4. Recognize that people hold diverse opinions about the impact of information technology on individual and societies.

Instructional Approach

- Class discussions/notes
- Direct instruction
- Computer exercises/projects
- Internet research/lessons
- Quizzes and exams

Curricular Requirements **Software/Textbooks:**

Many supplementary materials, including online assignments

Required Materials: Pencils/Pens for written work and a desire to learn

Homework: The majority of homework will consist of studying for quizzes and tests or completing vocabulary assignments.

Assessment/Grading Policy: If a student is absent they should email the homework to the instructor the day the assignment is due or as soon as they return to school. **Late work is NOT accepted. Late Work Policy for IAs** - Due the day they are due. If a student does not turn the IA in on the due date, the IA is not sent to IB and thus, they will be missing a component necessary for their IB score in that subject.

Attendance Policy

All students are expected to be in their seats and ready to work when the bell rings. Absences must be cleared with the attendance office. Students receiving more than the allowed number of absences with three or more "cuts" and earning a passing grade will receive an "NA" grade. Students will be responsible for checking with the teacher and scheduling a time to make up assignments in the computer lab during break, lunch or after school. - IB courses with an IA: Students cannot submit the same work (or parts of the same work) for two different assessment components. In other words, you cannot use the same IA or parts of an IA to satisfy two different IB assessments. Any duplicated work will NOT be submitted to IB and students will be missing a component.
